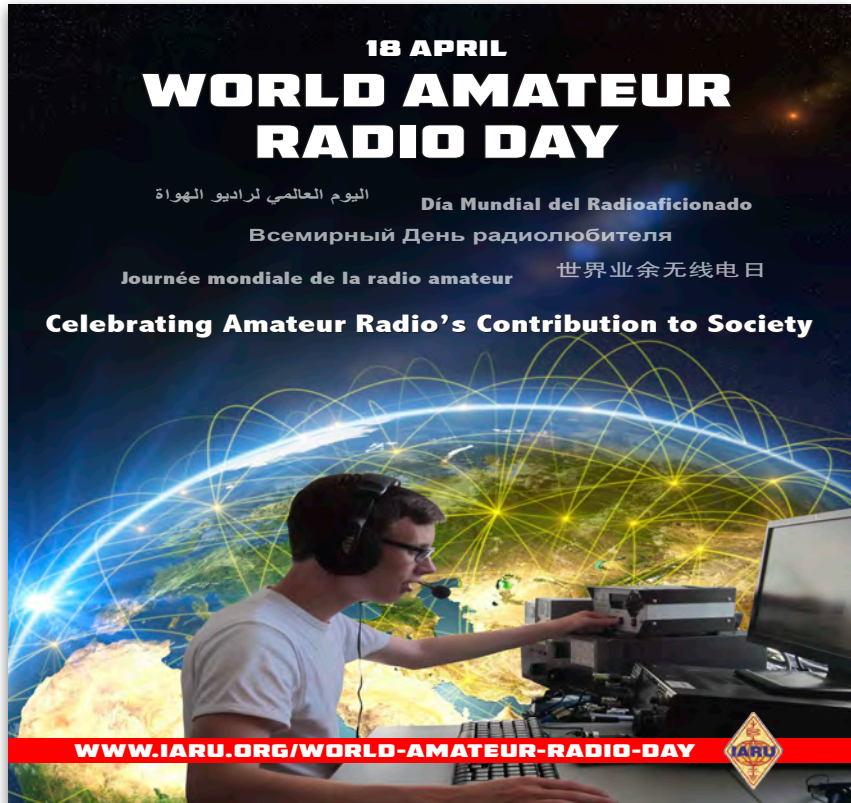

The Harrisburg Radio Amateurs Club Inc., [HRAC] formed 1 July 1946, as an association of individuals commonly interested in amateur radio, based in Harrisburg, Pennsylvania. It is an ARRL affiliate club.

At the end of World War II, many veterans returned to the Harrisburg area trained and used radio communications in the military. It soon became a common factor among local hobby enthusiasts. Fifty-eight charter members developed the original constitution and bylaws for the club. In 1960, HRAC became a non-profit corporation in Pennsylvania.

The club continues to promote amateur radio in the area in many ways. HRAC is involved with scouting's JOTA activities and promoting amateur radio with school clubs and organizations.

Since 1949, members have provided communications for the American Red Cross in Harrisburg for Dauphin County and Pennsylvania Emergency Management. In addition, we conduct periodic training sessions for emergency responders.

HRAC has three hamfests throughout the year: July's **Firecracker Hamfest** /Eastern Pa Section Convention is always the Saturday before the first Sunday in July. During the convention, you may hear special event station W3UU from the hamfest tailgating area. We set up and operate W3UU to demonstrate amateur radio and invite operators to join in and make contacts. Second: **Oktoberfest**. Third: the well attended **WinterFest** in January is an indoor tailgate fest.

Rule Changes for ARRL Field Day 2022:

- All Field Day stations are limited to a maximum 100 watts Peak Envelope Power (PEP) transmitter output, regardless of operating class.
- Class D stations can contact any other station for QSO points.
- **Media Publicity bonus point criteria have changed (7.3.2).** "100 bonus points may be earned for obtaining publicity from the local media. A copy of the actual media publicity received (newspaper article, etc.) must be submitted to claim the points. Any combination of bona fide media hits would qualify for the bonus points. For example, posting the details of your upcoming or ongoing Field Day activity, or your Field Day results, on a **club or news media site**, on Facebook, or via **Twitter and Instagram** would meet the bonus criteria. Available to all Classes." (**Post to your Club's website and newsletter!**)
- **Individual stations can contribute their scores to an aggregate score of their club by supplying the club's name on the entry form at time of entry.** (Can't make it to your Club's FD site but want to give points? Now you can from your home!)

Word to the Wise

When submitting contest logs, many contest sponsors will provide an email confirmation of your entry. It's always advisable to check your confirmation email or the contest's Logs Received page to ensure that your entry has been submitted and that your entry

category, club name, and location are correct. ARRL, CQ, and other contest sponsors allow you to resubmit your log with any corrections before the log submission deadline. The most recent uploaded log will be used for scoring purposes. After the deadline, some contest sponsors will release

raw scores that reflect the results before any log checking has been completed. If, after the deadline, you notice an error in your log submission, contact the contest sponsor to correct it before the results are tabulated and made public. — www.arrl.org/the-arrl-contest-update ■

WRTC 2022 Special Event Station Award Begins New Cycle

World Radiosport Team Championship 2022 (WRTC 2022) special event stations have been on the air to call attention to the international competition, now set to take place in July 2023.

Stations that already worked toward the WRTC 2022 Award in January and February may be contacted again. Stations need 50 points for the award. The point structure is 5 for CW contacts, 10 for SSB contacts, 12 for RTTY contacts, and 17 for FT8 (or mixed). Points accumulate each month. Your March score will be added to your February and January scores. Register and log in to hamaward.cloud and select "WRTC2022 Award" to access your score page and logbook. The WRTC 2022 Award organizers are asking participants not to send or email QSL cards. Further information will show up on the hunters' website.

Special call signs are active during this event. More than 100 Italian radio amateurs will activate special WRTC call signs, one for each Italian call district, concluding on July 10, 2022. A first-time award promoting WRTC 2022 will be available. Look for these call signs to be active during some contests, concluding with the 2022 IARU HF World Championship. Each participant's contact totals and award-hunter scores will be displayed on a real-time leaderboard. Participants can download the award in digital format. — *Thanks to The ARRL Contest Update* ■

CQ to Limit Contest Participation by Stations in Russia, Belarus and Donbas Region Due to Russian Invasion of Ukraine

"FOR IMMEDIATE RELEASE: March 17, 2022

CQ Communications, Inc., publishers of *CQ Amateur Radio* magazine and sponsor of the CQ World Wide DX and WPX Contests, announced today that in light of the invasion of Ukraine by Russia and Belarus, it will not accept competitive entries in any of its sponsored contests by amateur radio stations in Russia, Belarus or the separatist Donbas region of Ukraine (unofficial D1 prefix). Logs submitted by these stations will be accepted only as checklogs. In addition, contacts with these stations by other participants will have zero point value and will not count as multipliers.

This is in line with a similar action taken by the **Radio Society of Great Britain**, following the lead of other international sports federations around the world.

"We regret the need to take this action," said CQ Publisher Richard Ross, K2MGA, "and recognize that the vast majority of our fellow amateurs who are affected by it are innocent bystanders who had no role in their government's decision to invade another sovereign country. However, in light of the great suffering being inflicted without cause on the people of Ukraine by Russia's leaders, we cannot in good conscience stand by and do nothing."

The CQ policy will take effect with the 2022 CQ WPX SSB Contest on March 26 and 27. Future events will be considered on a case-by-case basis, depending on the situation at that time. — cqwp.com/blog/ ■

HARRISBURG HAM HISTORY

— April, 100 years ago —

3ACN

Radio Station 3ACN, owned and operated by George and Robert Doehne, began two years ago as a simple crystal detector. It is now one of the best radiophone receivers in this city and has transmitted as far as Mt. Gretna, Portland, Maine.

The receiving set is composed of an old style Reinartz tuner, detector and one stage amplifier, but in order to get a higher wave, a loose coupler, a detector and one stage of amplification is used. A new style Reinartz tuner and detector and two stage amplifier are now under construction for C. W. and phone work. Commercial stations can be copied.

The transmitting set consists of one-fourth K. W. Acme transformer, Murdock condenser, heavy copper strip oscillation transformer, variable speed rotary gap with control and kick back preventer. The antenna is a four-wire flat top, with an average height of thirty feet. A counter poise duplicating the aerial is suspended about ten feet above the ground. This counterpoise is used for receiving in conjunction with a wire connected with the heating system.

Volunteer Monitor Program Releases February 2022 Activity Report

"The Volunteer Monitor (VM) Program is a joint initiative between ARRL and the Federal Communications Commission (FCC)..."

• **Technician-class** operators in ... Massachusetts; ... Iowa, and ... Oklahoma, were issued Advisory Notices for FT8 operation on 20 meters. Technician licensees have no privileges on 20 meters.

• **Technician-class** operators in ... Indiana; ... Texas; ... South Dakota; ... Illinois, and ... California, were issued Advisory Notices for FT8 operation on 7.074

MHz. Technicians have only CW privileges on 40 meters.

• **General-class** operators in ... Pennsylvania; ... Arizona, and ... Georgia, were issued Advisory Notices for operation on 20-meter frequencies not authorized to General-class operators.

The VM Program Administrator had two meetings with the FCC and participated in two amateur radio club meetings via videoconference. The final totals for VM monitoring during January 2022 were 2,172 hours on HF frequencies, and 2,932 hours on VHF frequencies and above, for a total of 5,104 hours. — *Volunteer Monitor Administrator Riley Hollingsworth, K4ZDH* — *The ARRL Letter for 10 March 2022.* ■

FCC \$35 Amateur Application Fee Effective 19 April 2022



Public Notice 23 March 2022, states amateur radio application fees, including those associated with Form 605 application filings, will become **effective 19 April 2022**.

The \$35 application fee, will apply for a new license, renewal, rule waiver or a new vanity call sign. The fee will be per application.

VECs and **Volunteer Examiner (VE) teams WILL NOT COLLECT** the \$35 fee at exam sessions. Once the FCC application fee takes effect, applicants will pay the \$35 fee directly to the FCC via the CORES FRN Registration system (CORES Login).

HRAC's Laurel VE Team does not charge for testing — but the FCC \$35 fee is separate and will be up to applicant to make direct payment to the FCC.

When the FCC receives the new examination information from the VEC, it will **email** a link with payment instructions to each successful candidate who then will have 10 calendar days from the date of the email to pay. **(A valid email is RE-**

QUIRED per §97.23.) After the fee is paid and the FCC has processed an application, examinees will receive a second email from the FCC with a link to their official license. The link will be good for 30 days.

Additionally, the FCC stated that applications processed and dismissed will not be entitled to a refund. This includes vanity requests where the applicant does not receive the requested call sign.

Further news and instructions will follow as the FCC releases them.

SUMMARY:

Individuals: \$35 fee for new, modification (sequential call sign change), renewal, rule waiver, and vanity call sign applications. All fees will be per application.

Clubs: \$35 fee for new, renewal, rule waiver and vanity call sign applications. All fees will be per application.

EXEMPT from fee: Administrative updates, license upgrades, and a change of name, mailing or email address, or license cancellation, or change of trustees for clubs.

hackaday.com reports 4.625 kHz, a familiar frequency of the Russian jammer called "the Buzzer" has now become a battleground for others trying to jam the jammer with everything from conventional broadcast material to digital Stop War graphics. ■

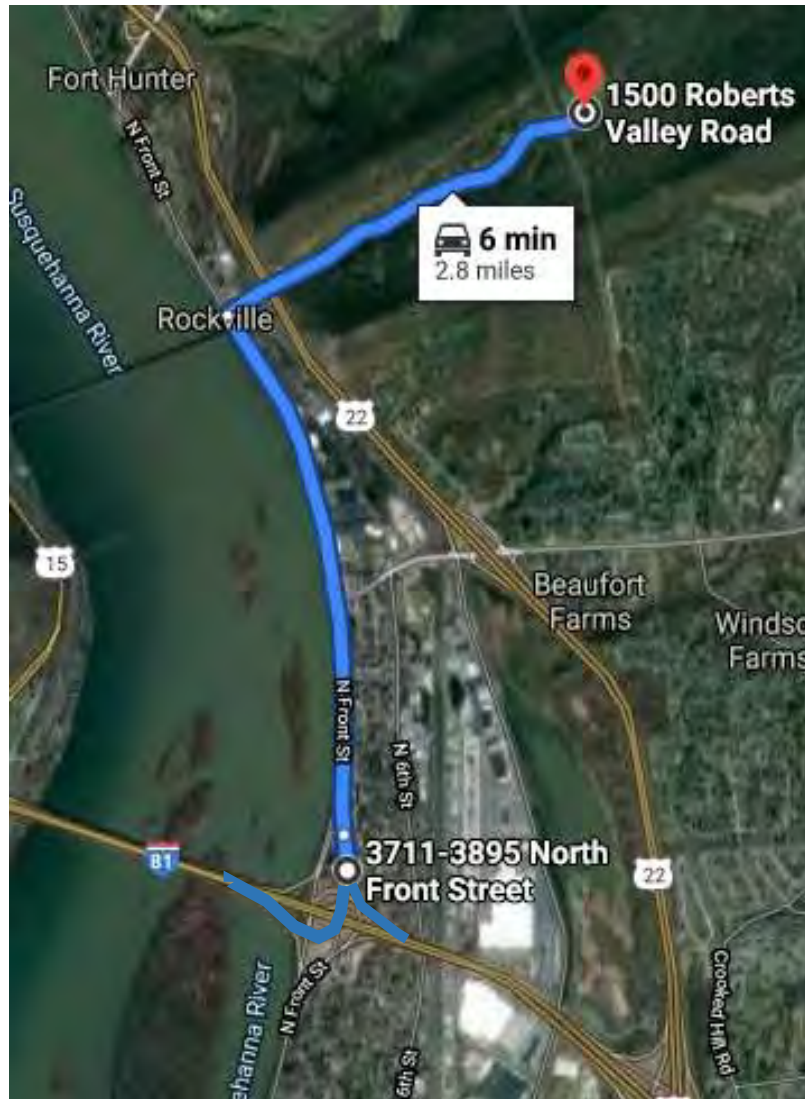
