The Harrisburg Radio Amateurs Club Inc., [HRAC] formed 1 July 1946, as an association of individuals commonly interested in amateur radio, based in Harrisburg, Pennsylvania. It is an ARRL affiliate club.

At the end of World War II, many veterans returned to the Harrisburg area trained and used radio communications in the military. It soon became a common factor among local hobby enthusiasts. Fifty-eight charter members developed the original constitution and bylaws for the club. In 1960, HRAC became a non-profit corporation in Pennsylvania.

The club continues to promote amateur radio in the area in many ways. HRAC is involved with young people by helping with scouting's JOTA activities and promoting amateur radio with school clubs and organizations.

Since 1949, members have provided communications for the American Red Cross in Harrisburg for Dauphin County and Pennsylvania Emergency Management. In addition, we conduct periodic training sessions for emergency responders.

HRAC has three hamfests throughout the year: July's **Firecracker Hamfest** / Eastern Pennsylvania Section Convention is always the Saturday before the first Sunday in July. During the convention, you may hear special event station W3UU from the hamfest tailgating area. We set up and operate W3UU to demonstrate amateur radio and invite operators to join in and make contacts. Second: **Oktoberfest**. Third: the well attended **WinterFest** in January is an indoor tailgate fest.

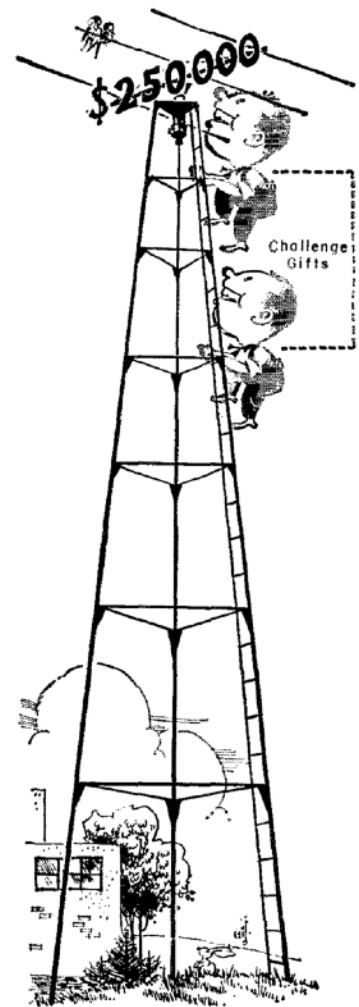

Commercial Interests Petition FCC for High Power Allocation on Shortwave Spectrum

The *ad hoc* group “Shortwave Modernization Coalition” petitioned the Federal Communications Commission (FCC) to allow data communications on multiple bands within the HF 2 - 25 MHz range with up to 20 KW, including in bands immediately adjacent to spectrum allocated to the Amateur Radio Service. This group appears to represent high-speed stock trading interests.

The FCC has assigned it RM-11953. Comments are due by July 31, 2023, and reply comments by August 15.

While the petitioners exclude the amateur bands, high power operations on immediately adjacent bands are proposed.

The ARRL is reviewing the petition.

OPINION: Shortwave “Modernization” Coalition (SMC).

I had to chuckle in a few spots as I read all 103 pages of this technical tome (FCC RM-11953). Namely, the science jargon carefully explicated by lawyer-speak justification for potentially shaving off a few nano-seconds of stock trading data that doesn’t interest anyone except this elite group. And, the apparent expense they went to justify the high frequency (HF) grabs between 2-25 MHz. Are they so desperate for air-time that the satellites, the Internet, and landlines are inadequate? SMC advocates “...for fixed, long-distance” non-voice stations (p. 2). The SMC is comprised of seven companies — all Wall Street traders and fellow-travelers.

HF communications have been declining for decades.

I started as an avid SWL in 1966, a ham radio operator by 1994, and I have witnessed the marked decline of commercial and military radio services on the HF bands. Why? Because other communication transmission models have surpassed the use and stability of HF. Yes, many businesses still use HF, but not nearly like 50+ years ago. SMC claims these HF frequencies are a stable “...superior medium for [the] transmission of relatively low-bandwidth data over long distances with minimal delay as compared to other transmission technologies... and underutilized.” (p. 4, 6) Say that when the Solar Flux dumps to 70, and the K-factor is 10 or static noise makes the packets resend repeatedly for verification, or some nefarious entity hi-jacks the frequency and data.

SMC is not in the general interest of the public.

“If adopted, the proposed amendments would enhance market makers' ability to quickly access real-time financial data and to continue to act in a manner that provides liquidity and helps to improve asset prices, to the benefit of centralized markets and market participants.” (p. 3). And on pages 20-22, SMC states outright that *they are* the public interest. So, are emergency, military, and other commercial services not in the public interest? We don't count? The only public interest is THEIR interest, serving THEIR special interest.

SMC threatens the ham band edges.

Proposed, non-channelized transmissions edge dangerously close to the Amateur Radio Service (ARS) and Military Auxiliary Radio System (MARS) bands:

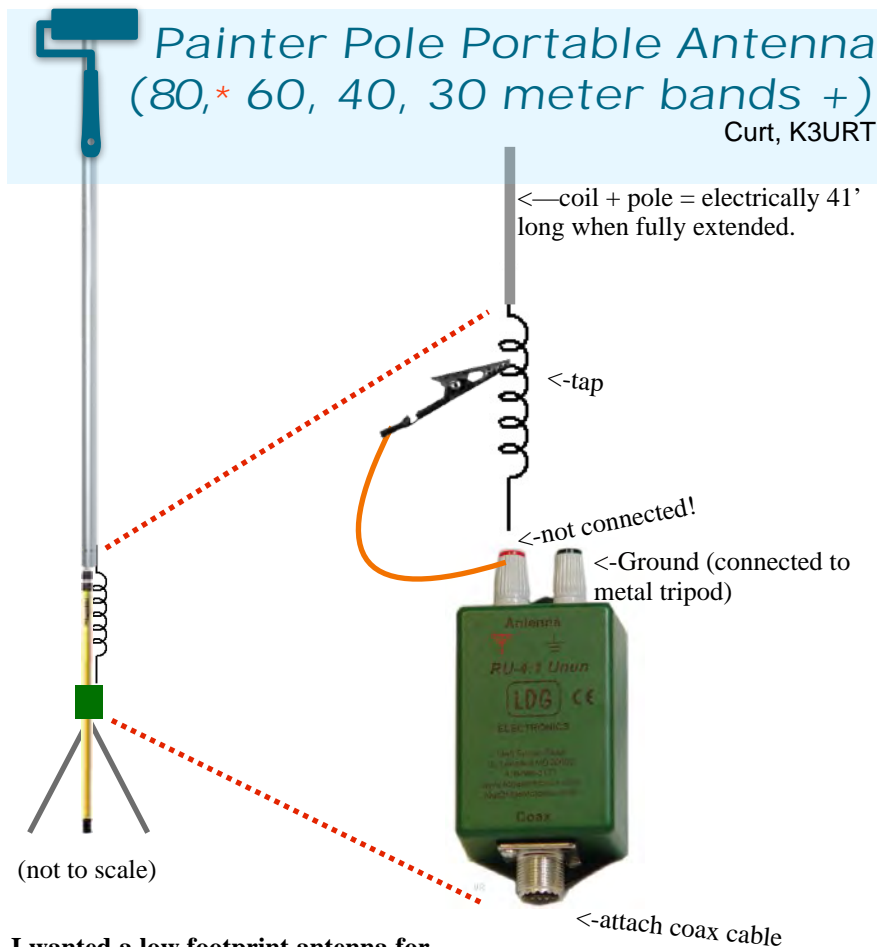
- **4.000-4.063** MHz (top end of the 75-meter band);
- **5.005-5.450** MHz (the already shared 60-meter band);
- **10.150-11.175** MHz (top edge of the 30-meter band);
- **14.350-14.990** MHz (top end the 20-meter band);
- **18.030-18.068** and **18.168-18.780** MHz (both ends of the 17-meter band!);
- **20.010-21.000** MHz (low end of the 15-meter band);
- and **23.350-24.890** MHz (low end of the 12-meter band).

(Appendix E, p. 35).

Okay — they are not *in* the ARS bands, but how about proposed 20 kilowatt transmitters pounding away at 18.168.1 MHz band edge? We know the real-world effect of that.

I wanted a low footprint antenna for portable operations.

This is nothing new under the sun. There are many designs, configurations and ways to make a very portable antenna. It's up to your ingenuity and junk box! The footprint is about 9 square feet. Additional bands can be made by shortening the aluminum pole extension section. I am not a mechanical person, so anyone can do this better!

*Phone portion of the 80 meter band.

Hardware and Notes:

- 1, Tripod, metal (old Radio Shack model, about 3' tall).
- 1, Coil, 40 turns at 2.5" wide, 10" long, 12 gauge wire (I believe this is a Barker and Williamson Airdux 2004TL. I bought this at a hamfest years ago.)
- 1, Painter's Pole extension, 23.2' (bottom 7' is fiberglass, the rest aluminum); lowes.com "Mr. LongArm" (used here); Home-Depot.com has a similar "Unger" 24'.
- 1, LDG 4:1 Unun (NOT a balun).
- 1, test lead (~12" long) from unun antenna to a position on the coil
- 1, test lead (~ long) from unun ground lug to the metal tripod. Oddly, I did not find a need for long counterpoise after much testing! The 50' coax outer shield did the job.
- ~50' RG58 coax cable.

The coil slips over the pole and is attached to the **non-conductive fiber-**

glass section with plastic ties. The Unun is similarly connected.

Once set up, an analyzer attached to the coax will give various readings depending on where the test lead was attached to the coil. The test lead would read a lower frequency in the lower position down the coil. **You are tuning for resonant frequency for a specific band without an external tuner (and without the internal tuner as well in most cases).**

The coax, for the best results, was stretched out away and the surplus can be coiled up next to the operator's chair. Avoid a human body or anything else largely conductive within 10' around the antenna — otherwise de-tuning will occur and the antenna and the SWR readings will be all over the place. Using **ferrite cores** at the rig end is also **highly suggested**.

Tested with 50 watts FT8 on 40 and 30 meter bands, using a Yaesu FTDX-10 at home QTH; and 2023 HRAC Field Day site, 50 watts, CW on battery.

Results: not a Yagi, but held its own. Breaks down quickly.

Depending upon your tripod, be sure to secure the antenna for safety.
